Recent 2013 Projects

The Canyon SCD worked with the Natural Resources Conservation Service (NRCS) through the Environmental Quality Incentives Program (EQIP). For the general EQIP there were 25 contracts in the amount of \$1,173,367, on 2,344 acres. Through EQIP organic there were 4 projects in the amount of \$66,327, on 102 acres. This year Canyon received the opportunity for EQIP National Water Quality Incentive with 10 contracts in the amount of \$920,175, on 790 acres. The projects include: pivot/sprinkler irrigation systems, drip irrigation systems, waste storage facilities, Irrigation Water Management (IWM), Nutrient Management, Integrated Pest Management (IPM), and Soil Health Practices and improvements to name a few.

In FY 2013 Conservation Technical Assistance (CTA) was provided to 20 different producers on approximately 240 acres. This assistance consisted of site visits, conservation planning, engineering designs, and analysis and recommendations for irrigation systems, planting and planning. Various irrigation systems included recommendations for improved gravity systems, sprinklers, and drip systems.

Through the 319 Program there were four more Conservation Plans completed and irrigation systems installed consisting of a drip system on 56 acres of mint and sugar beets, a wheel line system on alfalfa of 25 acres, pivot/sprinkler system on 31 acres, and an improved surface system (mainline, gated pipe, and sediments basins) on 51 acres. Irrigation water management plans and follow-up on those plans are still on-going with some innovative equipment being employed. The "Montana Washtub Scheduling Method" is being used on the wheel line field and will be used for a demonstration for simple IWM. On the Sugar Beet and Mint fields, there are Watermark Sensors installed to show water use and irrigation scheduling.

- Participated in the 4th annual Agriculture Symposium over 100 participants.
- Sent two students to the Natural Resource Camp in Ketchum, sponsoring their registration.
- In July, the Canyon SCD had an education booth and display at the County Fair with over 400 participants for the 4 day event.
- The Canyon SCD newsletter goes out quarterly to over 650 subscribers.

Future Projects

Future projects consist of some sediment basins, irrigation water management on six existing projects and the possibility of additional 319 funding. In the absence of 319 funding, there may be some irrigation evaluations to be done and used for demonstration.

Continued efforts will be made with the assistance of a Conservation Technical Assistance Program. The Canyon SCD Resource Enhancement Project is designed to accelerate natural resource treatment and improvements. This project will address high priority natural resource issues documented by TMDL plans and Watershed Planning documents.

Canyon SCD will continue partnering with agencies, and plan and seek funding to address resource concerns.

Canyon SCD will continue to promote natural resource conservation through outreach & education programs for youth and adults.
