#### **Recent 2016 Projects**

The Canyon Soil Conservation District (SCD) worked with the Natural Resources Conservation Service (NRCS) through the Environmental Quality Incentives Program (EQIP). Under the Division III cropland general EQIP there were ten contracts in the amount of \$500,029.00, on 421 acres. Under the state socially disadvantaged irrigated cropland there were no contracts. Through EQIP organic there was one Soil Health project in the amount of \$8,200.00, on 39 acres. This year Canyon County received the opportunity for EQIP National Water Quality Incentive funding with six contracts in the amount of \$380,463.00, on 398 acres. The projects included: pivot/sprinkler irrigation systems, drip irrigation systems, Irrigation Water Management (IWM), Nutrient Management, Integrated Pest Management (IPM), Soil Health Practices, and other improvements.

In FY 2016 Conservation Technical Assistance (CTA) was provided to thirty nine different producers on 687 acres. This assistance consisted of site visits. conservation planning, engineering designs, and analysis and recommendations for irrigation systems, planting and planning. There were various irrigation systems including recommendations for improved gravity systems, sprinklers, and drip systems.

Through the 319 Program there were two completed payment applications in amount of \$103,305.00 on 186 acres. Also, there was monitoring work done with a Canal Company in Parma to install a large sediment basin.



This field slope is 5-7% going directly towards river. This cover crop helps to control erosion & sediment runoff.

The Canyon SCD Outreach educates the landowners, public, and students in conservation awareness.

- \*\* Canyon SCD tour of projects with Curtis Elke, NRCS State Conservationist was successful. The tour included conversion of surface irrigation to pivot system, proposed sediment basin, permanent drip on hops, cover crop field and drip systems on mint and beets.
- \*\* Canyon SCD partnered with Ada Soil & Water Conservation District for the No-Till Organic Cover Crop & Roller Crimper Field Day. Lori handled over 77 preregistrations for the July 14<sup>th</sup> event.
- \*\* Canyon SCD supervisors/landowners participated at the July 23 ISWCC Conservation Tour with over 75 attendees.
- \*\*Canyon SCD/319 Project Tour Best Management Practices with Soil Health
- \*\* Sponsored the District Poster Contest for 11 students.
- \*\* Sponsored the District Speech Contest for one student.
- \*\* Sponsored the Natural Resources Camp scholarship for one student at the week-long event.
- \*\* Participated at the Western Idaho Ag Expo with an educational booth consisting of a Power Point Presentation & display for 100 attendees at the two day event.
- \*\* Participated in the 7<sup>th</sup> annual Soil Health Symposium with 125 participants, along with the Canyon SCD Soil Health Display.
- \*\* In July, the Canyon SCD had an education booth and display at the County Fair with 150 participants for the four day event.
- \*\* The Canyon SCD newsletter goes out quarterly to 600 subscribers.
- \*\* Canyon SCD Soil Health Display was borrowed by NRCS for the 5<sup>th</sup> Annual Women in Agriculture Conference.
- \*\* Canyon office staff participated in 4 of the 5 Ada 5<sup>th</sup> grade field days with over 800 students participating in the 4 day event.
- \*\* Washington D.C. folks visit the Caldwell Field Office and a proposed sediment basin in the Canyon Soil Conservation District.

#### **Future Projects**

Canyon SCD will continue to seek future projects for Agricultural Best Management Practices (BMP's) for Water Quality Improvements and the possibility of additional 319 funding. In the absence of 319 funding, there may be some irrigation evaluations to be done and used for demonstration. There are numerous projects for 319 funding if available. Center pivot sprinklers, wheel line sprinklers, annual drip systems, and permanent drip systems have been requested and there is a continued interest in products utilizing this funding.

Continued efforts will be made with the assistance of a Conservation Technical Assistance Program. The Canyon SCD Resource Enhancement Project is designed to accelerate natural resource treatment and improvements. This project will address high priority natural resource issues documented by Total Maximum Daily Loads (TMDL) plans and Watershed Planning documents.

Canyon SCD will continue partnering with agencies, and plan and seek funding to address resource concerns.

Canyon SCD will continue to promote natural resource conservation through outreach & education programs for youths and adults.
